A parcel of land at the intersection of Eubank Street and Shartel

Avenue, more particularly described as follows: All that part of the

Thirty (30) foot private right of way of the Oklahoma Railway Company

in the center of Shartel Avenue, lying South of the South line of Block

City, Oklahoma, produced east to the east line of said right of way

and North of the North line of Block numbered Three (3) in Central

Park Addition to Oklahoma City, Oklahoma, produced West to the West
