All policies (except Workers Compensation/EL) include a blanket automatic additional insured endorsement [provision] that confers additional insured status to the certificate holder only if there is a written contract between the named insured and the certificate holder that requires the named insured to name the certificate holder as an additional insured. In the absence of such a contractual obligation on the part of the named insured, the certificate holder is not an additional insured under the policy.

All policies include a blanket automatic waiver of subrogation endorsement [provision] that provides this feature only when there is a written contract between the named insured and the certificate holder that requires it. In the absence of such a contractual obligation on the part of the named insured, the waiver of subrogation feature does not apply.

All policies include a blanket notice of cancellation to certificate holders' endorsement, providing for 30 days' advance notice if the policy is canceled by the company other than for nonpayment of premium, 10 days' notice if the policy is canceled for nonpayment of premium. Notice is sent to certificate holders with mailing addresses on file with the agent or the company. The endorsement does not provide for notice of cancellation if the named insured requests cancellation.

All policies (except Workers' Compensation/EL) contain a special endorsement with "primary and non-contributory" wording.

The General Liability policy includes Sudden & Accidental Pollution Liability, including First Party Pollution Clean Up Costs - No sublimit with 30-day discovery/90-day reporting when first known by the insured.

The General Liability policy includes Contractual Liability - Railroads with no exclusion for work within 50 ft and includes indemnity of railroad in connection with construction.

The General Liability policy includes Non-Operating Working Interests as an insured - per written agreement.

The Auto Liability policy and Energy Package policy includes a blanket automatic loss payee endorsement [provision] that confers loss payee status to the certificate holder only if there is a written contract between the named insured and the certificate holder that requires the named insured to name the certificate holder as a loss payee. In the absence of such a contractual obligation on the part of the named insured, the certificate holder is not a loss payee under the policy.

The Auto policy includes Pollution Broadening Coverage per form CA 99 48. The Auto Liability policy includes Motor Carrier Act Endorsement per form MCS-90.

The General Liability, Commercial Auto, and Employers Liability Policies are scheduled under the Excess Liability Policy.

The Workers Compensation policy includes Alternate Employer coverage per form WC 00 03 01.
