Board Purpose:	(1) to provide recommendations to the City Council or the City's designated convention and visitor promotion agency, as appropriate, regarding the promotion and enhancement of the City's convention, tourism and visitor based economy; (2) to approve an annual budget to be submitted to the City Council together with the goals, objectives and performance measures for the forthcoming year in support of the proposed annual funding contract; (3) to receive and provide to the City Council at least quarterly a summary of the activities of the agency including a financial accounting of contract funds and the performance measures for the year to date; (4) in accordance with section 52-81.1(3) of this Code, to recommend to the City expenditure of Hotel Tax proceeds to enhance the local economy through increased convention and/or tourism (visitor) activity in the City.
