Enabling Legislation:	Created by Ordinance #19,351 dated January 30, 1990; amended by Ordinance #19,912 dated March 23, 1993, Ordinance #22,566 dated October 5, 2004, Ordinance #22,730 dated May 24, 2005, and Ordinance #24,070 dated June 1, 2010.
