Board Purpose:	To gather information regarding recreation in and around lakes and other property owned or controlled by the City; to study needs on such City land where game and fish may be present or propagated; to recommend to the City Manager and Council rules and regulations governing fishing, boating, hunting and other recreational activities and governing the propagation and preservation of fish and game not inconsistent with the protection of the water supply; and to recommend methods of controlling the waters and property of the City for the best enjoyment and use by its citizens.
Enabling Legislation:	Created by Ordinance #11,579 dated March 14, 1967; amended by Ordinance #19,336 dated January 2, 1990, and Ordinance #23,451 dated September 25, 2007. Codified as Chapter 38, Article III, Section 38-66, Oklahoma City Municipal Code, 2007.
