Resolution and Trust Indenture, dated March 19, 1985, created the Riverfront Redevelopment Authority and provides for seven Trustees. These are for 6 year terms. The Mayor, and two Council member shall be nominated by the Mayor and confirmed by the City Council to serve as ex-officio Trustees; at least two of the remaining Trustees shall be residents of The City of Oklahoma City. All shall be nominated by the Mayor and confirmed by the City Council. Third amendment to the trust, dated December 8, 1987, provides the Mayor may choose any officer or employee of The City of Oklahoma City to serve as a Surrogate Trustee in his absence.
